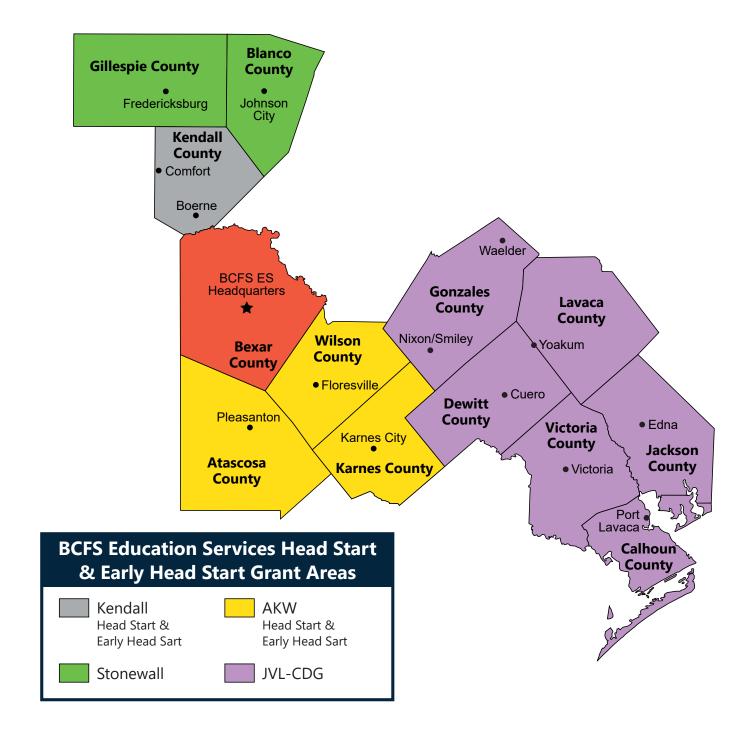

### **Reviews**

In December 2020, BCFS Education Services had its Focus Area 1 review. Results yielded three items of noncompliance, all addressing the delivery of mental health services by a licensed mental health provider in the service area. Our corrective action plan addressed the non-compliance through the following updates to human resources management practices:

- 1. Make the requirements for a Licensed Mental Health Coordinator more descriptive.
- 2. In service areas where we cannot secure a Licensed Mental Health Coordinator because of a lack of qualified applicants, hire a Health and Wellness Coordinator to facilitate the activities of our contracted Licensed Mental Health Consultant.

## Program Governance

Our program governance provides the infrastructure to ensure the program management demonstrates care, prudence, and good business judgment. Our Board of Directors and Policy Council membership is responsible for acting in the interest of the children, the organization, and the Head Start program: safeguarding the organization's mission, preserving the program intent, and monitoring adherence to the law.
